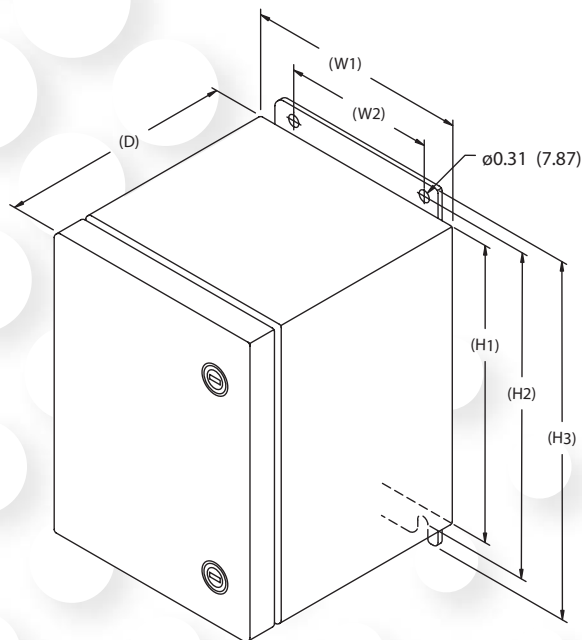

Should any failure of the Product to conform to this warranty appear within the standard warranty period, Current Technology shall either repair or replace the defective Product, or part thereof, upon return to Current Technology manufacturing facility in Richmond, Virginia with transportation charges pre-paid. The applicable warranty period is outlined below in the warranty period section.
